Rockin' Bell River Resort Campground Rules, Policies & Regulations

Our goal is to provide campers with a clean and safe environment to make memories with family and friends! We are obligated to follow the local codes and regulations for campgrounds. Please see below for Campground rules. Please note, this is not a comprehensive list. Management reserves the right to change any of these rules before, during, or after the season. Any rule change will be posted in the office. Any situations not covered here will be up to management's discretion to resolve. Campers agree to comply with these rules and regulations as outlined below.

These rules and regulations are instituted for the safety and security of all residents, visitors, staff and management of Rockin' Bell River Resort Campground. Repeated violations of these rules will result in the removal from the Campground of individual or individuals whether registered campers or visitors without refund. Re-admittance to the Campground will be at the discretion of management.

Amenities:

- Registration as a camper at Campground includes use of amenities including barbecue pit, fire pit and pavilion area, restroom/shower house facility, laundry facility, and walking trails (some amenities being subject to an additional fee).
- As noted in the waiver and agreed to by Camper, Camper uses these amenities voluntarily and at their own risk. Campground is not responsible for any injuries that may be sustained by Camper and anyone in their care, including children or guests, in their use of amenities.

Bicycles:

- The speed limit is 5 miles per hour and will be strictly enforced.
- Children aged 14 years and younger must wear a helmet when riding a bicycle.
- Riding after dark is prohibited. Return to site when night lights come on.
- Skidding tires in the stones will require the rider to rake the stones back into place.
- Misbehavior will lead to bicycle privileges being taken away.

Glamping/Camper/Cabin Unit Policy:

- No one under the age of 18 is allowed in the glamping unit without adult supervision.
- No smoking in units. We take pride in our units and would appreciate it if campers do the same.
- Units must be left clean with refrigerator and garbage emptied.
- Basic bedding will be provided.
- No pets allowed in units.
- Security deposit will be refunded after inspection and approval.

Laundry/Restroom/Bathhouse Facility

- Facilities are available to use as a privilege; failure to use facilities in an appropriate/respectable manner will result in loss of privileges.
- No pets allowed in the facilities. DO NOT bathe pets in facilities.
- Children must be accompanied by an adult.
- Any issues in the facilities need to be reported to staff immediately.

Hot Tub Usage

- Shower Before Use: Guests should shower before entering the hot tub to help maintain water cleanliness and hygiene.
- Do not enter if water temperature is 104 or above.
- No Food or Drinks: Avoid bringing food or drinks into the hot tub area to prevent contamination and keep the water clean.
- NO glass containers.
- Appropriate Attire: Wear suitable swimwear while using the hot tub. Avoid street clothes, which can introduce dirt and oils into the water.
- Limited Time: Limit your hot tub session to a reasonable time, typically 15-20 minutes, to avoid overheating or dehydration.
- No Alcohol or Drugs: Avoid using the hot tub while under the influence of alcohol or drugs. It can be dangerous and impair your judgment.
- Do not use if pregnant.
- Supervise Children: If children use the hot tub, ensure they are always supervised by a responsible adult.
- No Diving or Jumping: Do not dive or jump into the hot tub, as it can be hazardous due to the water's depth and temperatures.
- Avoid Soaps and Oils: Refrain from using soaps, oils, or lotions before entering the hot tub, as these can affect water quality.
- Shut the Lid: Securely close the hot tub cover after use to retain heat and keep debris
 out.
- Medical Concerns: Guests with certain medical conditions, such as heart problems, should consult a doctor before using the hot tub.
- Shut Off After Use: Ensure the jets are turned off after use to conserve energy.
- Emergency Information: Familiarize yourself with the location of emergency shut-off switches and contact information for property management.

Campfires:

- Campfires must remain inside your fire ring and should not use wood containing nails.
- Do not move the fire ring. Campers who move the fire ring will be immediately required to leave the Campground.
 - Fire privileges will be subject to weather conditions!

Cancellation Policy:

• All cancellations require fourteen (14) days' notice.

• Refund will be granted at Campground management's discretion less a \$20 cancellation and online reservation fee.

Check-in and Check-out Times:

- Check-in time is from 1:00 p.m. until 8:00 p.m. daily.
- Check-out time is at noon. Please notify the Campground office if you need to stay past noon on your checkout day.
- Please do not move to another site without first notifying the Campground office.

Children:

- The Campground and staff are NOT RESPONSIBLE for watching or supervising children AT ANY TIME. Children under the age of sixteen (16) must be always supervised by a responsible adult and must be on the Site they belong to every night by dusk.
- Battery operated cars for children are strictly prohibited.
- NO Skateboards allowed.
 - Children must be respectful of grounds and facilities as well as other guests. Disrespect to anyone at any time will not be tolerated.

Emergency:

• In case of emergency, call 911 and contact the Campground office.

Firearms/Hunting:

• Hunting is strictly prohibited on the Campground.

Fireworks/Lanterns:

• Only allowed on Campground the week of Fourth of July and only when weather permits. Fireworks may not be discharged after 10 pm.

Lost or Stolen Items:

• Campground is not responsible for lost or stolen items.

Noise:

- Please be considerate of your fellow campers.
- On Friday and Saturday, quiet time begins at 11:00 p.m. and ends at 8:00 a.m. From Sunday through Thursday, quiet hours are from 10:00 p.m. until 8:00 a.m. with an exception for Sunday on holiday weekends.
- When returning to your Site, please be safe and considerate of your neighbors.

Parking:

You may park up to two (2) cars at a time per Site.

Pets:

- Campers are allowed a maximum of two (2) dogs per Site.
- Campers must produce a copy of the pets' current rabies vaccinations upon entrance to the Campground to be filed with the office.
- Do not leave pets unattended or tie pets to trees.
- When visiting a site that has a pet, call out to the person or pet on the site before entering.
- All pets must be kept confined, tethered within the site boundaries and two (2) feet from the edge of the road, and leashed when walking on the Campground.
- Leashes must be no longer than six (6) feet long and walkers must be of sufficient stature and size to always maintain positive control and have a grip on the leash. We do not recommend retractable leases to walk pets on the Campground.
- Use the trail, road or tenting area to walk your pet. Cutting across anyone else's site is prohibited by any person or pet.
- Always clean up after your pet on all parts of the Campground, and properly dispose of waste in the dumpster. Failure to do so will result in a cleaning fee of \$50.
- If your dog barks, becomes a nuisance to neighbors or is aggressive towards other dogs or people, you must attend to the dog promptly. Continued unwanted behavior may result in you being asked to leave the Campground with no refund.
- Aggressive pets or those that have previously bit or attacked people or pets are prohibited from being at the Campground.
- No pets allowed in the buildings/bathhouse facility, Cabins or playground mulch/gravel area.
- Pet owners agree to abide by the above rules and always assume full responsibility for their pets.

Photos and Videos:

• As agreed, to in the Photo Release, entrance onto the Campground constitutes permission for Campground management to photograph, video, etc. the camper or visitor while they are on the premises, and to use any resulting pictures for any lawful purpose without compensation to or approval from the camper or visitor.

Pavilion Area:

- Hours are from 8:00 a.m. until 10:00 p.m.
- Trash must be placed in garbage cans. No trash may be left at the pavilion. Please clean tables, grills, etc. after use.
- No pets allowed on mulch or stone in pavilion area.
- May be used to play corn hole and other games.
- Broken equipment must be reported to management immediately.
- Please use safely and respectfully of others. No drunk or obnoxious behavior will be tolerated.

- All furniture/grills/ect. in the pavilion area, must stay at the pavilion.
- Water hydrant must be shut off when not in use and is not for children to play in.
- Pavilion may be rented for private parties upon request/booking. Signs will be posted if the pavilion is reserved. Otherwise, the pavilion is shared among guests.

Refunds:

• No refunds will be given for inclement weather or early departures.

Sanitation:

- Dumpsters are located to your left as you exit the Campground.
- Do not leave any trash outside or at the Campground overnight or burn it in the fire ring.
- Cigarette butts should be disposed of properly, not on the ground.

Sewage:

- Black tank valve is not to be left open.
- Use of Back Flush connection with hookup to water supply is not permitted.
- No washing of RV or any vehicles on Campground.

Speed:

• The speed limit is five (5) miles per hour. There are many children on the Campground so please adhere to this for their safety.

Trees:

- No defacing of trees, shrubs, rocks or removal of any plants or cutting of trees is permitted.
- No clothesline or anything tied from tree to tree is permitted.

Trespass:

Respect the privacy of others and do not trespass on their sites. Use the roads instead.

Undesirable Behavior:

• Any camper using profane language or who is intoxicated, or, in the opinion of Campground management, is acting in such a manner that may be injurious or annoying to others will be asked to leave the Campground immediately with no refund.

Visitors and Additional Guests:

- Registered campers are responsible for their guests.
- Visitors and additional guests, above the maximum occupancy of two (2) adults and two (2) children per site, must register and can be added at prices listed on the Campground website, at management's approval.

- Day visitors may use all of the Campground facilities if accompanied by a seasonal or overnight Camper who is registered to a specific site and must leave the Campground by 10:00 p.m. or else pay the overnight fee.
- The public is not permitted to drop in from the outside solely to use the Campground facilities.

Property

- Property is in a forested/wilderness area. Use property at your own risk to nature and fallen debris. This includes but is not limited to ticks, chiggers, snakes, deer, raccoons, opossums, skunks, etc. Property is surrounded on two sides by a highway, two sides are bordered by private property owners. The Jack's Fork River is less than a quarter of a mile away.
- Property is not fenced; boundaries are marked.
- Children should not be allowed to roam freely about the property, as boundaries are not fenced.
- The trails are rocky and may be steep in areas. Rockin' Bell River Resort assumes no responsibility for any injuries accrued by guests hiking the property.
- Rockin' Bell River Resort assumes no responsibility for lost quests.
